### What is this Product?

Ordinary Shares in Aberdeen Asian Income Fund Limited, an actively managed investment company registered in Jersey and listed on the London Stock Exchange. Its investment objective is to provide investors with a total return primarily through investing in Asian Pacific securities, including those with an above-average yield. Within its overall objective, the Company aims to grow its dividends over time. The Company has borrowed to purchase assets. The Company does not have a fixed life. Aberdeen Standard Capital International Limited may not unilaterally terminate the Ordinary Shares however the Company may be wound up with shareholder approval. Shares in the Company are bought and sold on a stock market. Investment in the Company is only suitable for investors who are comfortable with the risks and investment time horizon set out in this document and may not be appropriate if you plan to sell some or all of your shares within 5 years. ## What are the risks and what could I get in return?

The risk indicator assumes you keep the product for at least 5 years. The actual risk can vary significantly. The value of investments and the income from them can go down as well as up, and you may get back less than you invested.

## What happens if the Company is unable to pay out?

## What are the costs?

#### How long should I hold it and can I take money out early?

This product has no required minimum holding period but is designed for medium to long-term investment. Since the value of investments and the income from them can rise and fall over differing time periods, you should have an investment horizon of at least 5 years when buying an investment of this type.

## The minimum recommended holding period is therefore 5 years.

As the shares are listed on the London Stock Exchange, you may buy or sell shares on any normal business day that the London Stock Exchange is open for business.
